An order of Confiscation was passed by this office bearing the order no ZD2906230067178 dated 07-06-2023 under section 130 of the Central Goods and Services Tax Act and section 130 of the State Goods and Services Tax Act / Section 21 of the Union Territory Goods and Services Tax Act or under section 20 of the Integrated Goods and Services Tax Act, 2017.

Pursuant to the said confiscation order and judgement by the Hon'ble High Court of Karnataka via Writ appeal No 100067/2024 dated 08-06-2026, no person has come forward in compliance with the Hon'ble High court judgement and no person has come forward to pay the applicable fine and penalty in lieu of Confiscation Order. Therefore in exercise of the powers conferred under Sec 130 (7) of the CGST/KGST Act 2017, the undersigned proposes to dispose of the confiscated goods through public auction, on an "AS IS WHERE IS" basis in the interest of safeguarding government revenue. Interested and eligible bidders are hereby invited to participate in the public auction subjected to the following details and conditions.

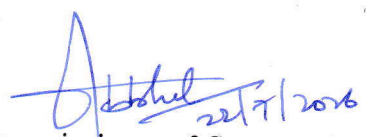

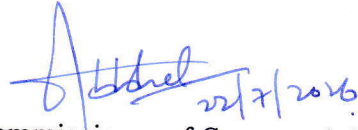

3. The Bidders Shall Furnish the Postal address, e-mail address and Mobile Number for communication.

Interested Bidders who wish to bid for the Arecanut, shall deposit Earnest Money of Rs.1,69,050/- by way of D.D. drawn in favor of Assistant Commissioner of Commercial Tax (Enforcement)-02, Ballari on/before 06/08/2027 before 5PM. The Bids which are not accompanied by DD for the EMD will not be considered for Auction.
5. The bidders are required to quote their bid in sealed cover by specifying the Rate in Rupees / kg for Arecanut (excluding GST).
6. **The undersigned reserves the right to accept or reject any bid or call off the Auction Sale before the Proceedings are completed, without mentioning any reasons**
7. The Bid amount quoted by the bidders will be displayed on the Notice Board. If the quoted Prices are reasonable, the Bidder with highest quoted price will be intimated to take the possession and lift the goods on payment of full bid amount.
8. The successful bidder, if registered under the GST Act has to pay the applicable GST under RCM before taking delivery of the goods.
9. The successful bidder, if not registered under the GST Act has to pay the applicable GST under RCM after obtaining Temporary registration under GST Act-2017 from the undersigned and submit the Payment Challan before taking delivery of the goods
10. The successful bidder shall deposit the bid amount through Online/Any mode of e-Payment within three days of intimation from the undersigned and shall remove

- material within two days after making Full payment of bid amount. In case the successful bidder fails to deposit the bid amount within the stipulated time, the EMD will be forfeited and the bid will be awarded to next highest bidder if the quoted rates are reasonable or fresh Auction Proceedings will be initiated
